Regarding: My Submission of My Audition Material to Proper Television Inc.

("Proper") considering me as a potential host or cast member in a television production and allowing me to submit video of myself for consideration by Proper's casting personnel and creative team ("Audition Material"), which for the purposes of this Release shall include all accompanying materials, including but not limited to written materials, photos, biography and video (the receipt and sufficiency of which is hereby acknowledged), I acknowledge and agree as follows:

1. The Audition Material is novel and original and I own exclusively, or I am the authorized signatory for the exclusive owner(s) of all rights to the Audition Material, including but not limited to copyright and all underlying rights to any story, concept or characters included therein. The Audition Material does not infringe upon or violate the rights of privacy of or constitute a libel or slander against, or violate any common law rights or any other rights of any person.
2. Upon my submission of the Audition Material, I understand and agree that it shall become the exclusive property of Proper and the copyright and all other rights (including performance rights) in it shall absolutely vest in and remain with Proper in perpetuity. Proper shall be entitled to deal with the Audition Material as it sees fit, without notice or further consent, and nothing herein shall obligate Proper to evaluate or review my Audition Material or contact me.
3. I acknowledge and understand that other persons, including employees of Proper, may have submitted to Proper or made public material that is similar to or virtually identical ("Similar Material") to the Audition Material (and/or the ideas or concepts included in the Audition Material). Proper shall have the unfettered right to use the Similar Material and such use shall not create any obligation of any nature whatsoever to me with respect to my Audition Material and I hereby waive any and all claims and/or rights of action against Proper for Proper's use of the Similar Materials.
4. I acknowledge and agree that the submitted Audition Material shall not be returned to me and I will retain an original copy of my Audition Material and I fully release and discharge Proper from any liability in connection with any loss or damage to the Audition Material.
5. I warrant and represent that I am not under the age of eighteen (18) years and I have the full right and authority to sign this document and to grant the rights purported to be granted in this release.
6. This Release shall be binding upon me, my heirs, executors, administrators, personal representatives and successors (collectively, my "Heirs").
7. I expressly waive and release Proper, its directors, officers, employees, agents, licensees and assigns from and against any and all claims which I or my Heirs have or may have for invasion of privacy, infringement of copyright or any other claim or cause of action arising out Proper's use of the Audition Material, including Proper's decision not to review or use them.
8. This Release shall be governed by, and interpreted in accordance with, the laws of the Province of Ontario and the laws of Canada, and any action or proceeding under or in respect of this Release shall be brought in the appropriate court of the Province of Ontario.
